Destination Imagination is one of the world's largest creative problem solving competitions. Teams work together over a period of several months to solve a technical, structural and/or theatrical central challenge and develop skills in solving improvisational instant challenges. These challenges stimulate the team's ability to think quickly and creatively with only minutes to prepare solutions. On Saturday, **February 23rd at Northwest High School and Pike Middle School**, teams will present at the regional tournament, performing their solutions to their Central Challenge and solving an Instant Challenge.

In consideration of permission granted by the Northwest Independent School District (the "NISD") for my child and I to participate in the identified events and activities associated with Destination Imagination ("DI"), specifically to include only the following: participation in and/or attendance at the DI meetings.

We agree to indemnify and hold the Northwest Independent School District harmless from any and all claims, demands, liabilities, actions, judgments, expenses (including attorneys' fees and cost of defense), and executions against the Northwest Independent School District, its trustees, officers, employees and agents from any claims made by third parties which result from the above-named student being permitted to participate in these activities, we expressly waive all claims to which we may otherwise be entitled, including but not limited to, claims for medical expenses and wages.

We understand that the Northwest Independent School District, its trustees, agents and employees are not waiving any sovereign or governmental immunity that it or they have under Texas or other applicable law.

The Role of the DI Team Manager

The Team Manager is expected to perform the following responsibilities:

- Arrange meeting sites and practice opportunities for the team
- Attend all tournaments and other DI activities in which the team participates
- Communicate regularly with the campus liaison
- Provide the campus liaison and team parents with a schedule of team meetings
- Communicate the rules regarding interference to all team parents
- **Attend the team managers' training- October 2nd at NISD Administration Building**
 - **Mandatory for New Managers: 6:00-7:30**
- Managers will communicate directly with parents regarding discipline problems regarding team members
- Complete all forms required for tournament participation
- Arrange an appraiser to attend a training and appraise at the Regional Tournament
- Submit to a criminal background check per district policy regarding volunteers

PARENT VOLUNTEERS MAKE THIS PROGRAM POSSIBLE.

A team manager or several co-managers will be assigned for each team. The team manager supervises the group, but is **NOT allowed** to help solve the challenges for the students. A team manager helps with scheduling, team building activities, and obtaining/transporting materials that the team wants to use in their solution to the problem.

Team managers may choose practice times that are convenient to their own work schedule – after school, evenings or weekends. (*Approximately one practice per week, with increased frequency in January prior to competition.*) **Your own child will be placed on your team.**

All team managers and parents working with the teams, will have to complete a district background check – please notify school contact when this is complete.
